How to add or delete a webinar package on your invoice.

To add the package: Check the "Webinar Package" box on your dues renewal invoice and add \$395 to your total. Or, you may request a new invoice from membership@nasfaa.org.

To delete the package: If you ordered the Webinar Package this past year, the 2014-15 webinar package will already be included on your dues renewal invoice. To delete the package, simply cross it off and deduct \$395.

You can still purchase individual webinars throughout the year. The cost per webinar will be \$115 for members (\$230 for non-members); however, the site license is for ONE computer only.
